

**Description of Discussion**

1. **Introduction:** The meeting held at Primal Eats started at about 9:05 am. The sign-in sheets included 76 attendees representing 40 Moshawquit Lake properties. 3. **2021 MLA Annual Meeting Minutes:** Bob Kemps #33 moved to accept the minutes for the 2021 annual meeting. Mark Emerick #117 seconded the motion. The motion passed unanimously. The minutes are accessible on the MLA website.

4. **Recent Garage Fire and Fire Protection:** Scott Follett (#58-59) reported that a garage on his property was lost in a recent fire. It took 40 minutes for the Keshena/Neopit volunteer Fire Department to respond. He also reported the Underhill Fire Department (UFD) is building a new facility and might be willing to provide fire protection to Moshawquit Lake residents. If so, that will also tie-in the ladder truck from the Gillett Fire Department. The process is for the MLA president to make a formal request in a letter to the fire chief. If the UFD agrees to provide fire protection to Moshawquit Lake, we should get a homeowner's insurance discount because the new UFD facility is closer to Moshawquit Lake than Keshena/Neopit Fire Department. Scott said he will donate the first year's discount to the UFD and suggested that MLA members do the same. **Action: Nick Romenesko #140.**
5. **Financial Update:** Joe Michel #16 reported that we've made great progress to collect the much higher 2022 dues we need to fund the chemical treatment program. There are just a few property owners who have not paid yet or have just made a partial payment.
6. **EWM Chemical Treatment Program:** In response to a question, Nick reported that the chemical we will use to treat the lake (ProcellaCOR) is safe for swimmers and the fish. For reference, Exhibit 2 is a copy of the warning sign we will post prior to the treatment. We used ProcellaCOR for 1 small area on Moshawquit Lake last year. Legend Lake is in its third year of using ProcellaCOR. Both lakes had good results with this chemical. It has also been used on a number of other Wisconsin lakes.
7. **EWM Education:** A recommendation was made to take your young children and grandchildren out on the lake to show then areas are infested with EWM. Talk about how driving boats and PWCs through those areas creates fragments that spread EWM to other areas in the lake. Our goal is to eliminate boat and PWC traffic through the infested areas which will be marked with buoys.
8. **Compost Site Fees:** The correct fee for the Legend Lake compost site is \$65, not \$50 as shown in the presentation deck.
9. **Buoys:** Our goal is always to get the buoys in place before water skiing season starts. Unfortunately, the buoy placement was delayed this year because of weather and boat repairs.
10. **Bear Sighting:** A bear was seen on May 27 in the evening on Moshawquit Lake Road near the junction with VV.
11. **Board Member Positions:** Anyone interested in either joining the MLA board or becoming a board officer should contact any current board member.
12. **Safe Boating Rules:** Do not let anyone sit on the front of a moving boat. There are known instances where people sat on the front of a moving pontoon boat. This is an unsafe practice because that person could easily fall off and get hit by the engine.
13. **Meeting Adjournment:** Corbin Keller #103 moved to adjourn the meeting. Bob Kemps #33 seconded the motion. The motion passed unanimously. The meeting adjourned at 10:06 am.

# MOSHAWQUIT LAKE EWM 2022 TREATMENT PLAN

- ProcellaCOR @ 3 PDU concentration on all 5 polygons (1-5) with 3 year guarantee as voted on by the members with overwhelming support
- \$127,000 total program cost
- MLA Dues for 2022 = \$1200 (\$1050 increase)
- Dues will be adjusted down to \$400 for the next few years to rebuild our funds
- Approx June 15 treatment date for the 5 areas with ProcellaCor. There will be signs posted and a notice in the local paper.
- Possible dash treatment in untreated chemical areas, we will evaluate as the season progresses.
- Avoid areas that are marked with bouys and avoid weedy areas at the surface (hopefully we will not have the need)
- Avoid phosphorous fertilizer. Seek options that are lake friendly if you feel the need to apply fertilizer.

## EDUCATION

WE CAN ALL PLAY A PART IN PREVENTING THE SPREAD OF EWM

Here are a few tips....

- Know how to identify EWM, and distinguish it from other aquatic plants
- Clean your boat, motor, and trailer to remove aquatic hitchhikers whenever you launch or remove your boat from the water
- Pick up floating fragments, each fragment can re-root, and form a new plant
- Avoid areas where EWM is near the surface, fragments cut by propellers will float and re-root. Last year colored bouys were placed at sites to mark dense patches and surface EWM.
- Monitor your lakefront, and pull any new EWM plants you find growing there

# Why Woody Habitat Near Shore is Necessary

- Algae and small plants grow on wood in shallow water, insects eat algae and plants, small fish eat insects.
- Both prey fish and predatory fish use woody habitat for cover
- Woody habitat near shore=yellow perch spawning habitat
- Without “natural like” woody habitat of trees falling into the lake, fish growth rates are negatively effected
- Tree drops were completed last winter, if a tree falls in the water, leave it if possible.




## Specific Fishery Improvements with Woody Habitat

- Improve size structures of all panfish and gamefish, especially bluegill and northern pike
- Improve yellow perch populations: they will lay groupings of eggs on the woody habitat, increasing chance of survival
- Walleye will also use woody habitat on shoreline, wait under a fallen tree for prey
- Juvenile walleye can hide from predators better .....**Especially the Age-0 walleye we stock each year**



**Legend Lake's compost is the closest – Saturday 10-2 through sept**

Oct.-Nov Saturdays 9-4 & Wednesdays 10-4  
\$50 fee for year. Free fill and compost (shovel only).



**Shawano county landfill is free for leaves, possibly a fee for branches. You can get top soil there as well. It is located on the south shore of Shawano on Rusch Rd off of Green Bay (Hwy 22).**

## SAFE BOATING AND LAKE RULES

Moshawquit Lake does have county ordinances that apply to our lake and differ from state laws.

- Wake and towing hours 10am to 7pm
- Must stay 200' from the shoreline when towing or creating a wake (includes PWCs)
- Drive in the counter clockwise direction around the lake to help keep the flow.
- Drivers must be of appropriate age and hold boat safety certificate:
  - To operate a PWC – must be at least 12 with boater's safety
  - To operate a motorboat – must be at least 16 years of age with boater's safety or be accompanied by someone 18 years and older with boater's safety

### Reminder:

- Towing behind a PWC: Must be a three person PWC and include a spotter.

There were unfortunate occasions in the past of near misses and inattentive drivers looking back at who they are towing and not where they were going. Please use a spotter and drive carefully!

Please be respectful of your neighbors with regards to your lighting. Please direct lights down and don't have lights shining out onto the lake. Light pollution ruins amazing views of our night skies and is blinding to people across the water.

In the winter time, aerators need to have a barrier around them with continuous rope/cord or similar material placed at least 2.5 ft and no more than 4.5 ft off the surface. Must be marked by an visual warning system that is lite, fluorescent, or reflectorized. It should not encroach on your neighbor's ice (without consent) in a way that would make the ice on their shoreline unsafe. This can be accomplished by using skirts to prevent the flow of water from your neighbors.

## A FEW OTHER ISSUES TO DISCUSS

As property owners we are afforded the ability to utilize the boat launch, which is on tribal property

When a boat is launched, the property owner must be present at the time. Guests launching their boats can be fined for trespassing.

Property and boat owners must inspect the watercraft for plants and empty live well and bilge tanks prior to launching

If you or a guest are stopped by a lake member inquiring if they are suppose to be on the lake should not be offended and simply tell the lake member the name of the property owner.

Please inform your guests of the lake rules

If you see a problem, please address it. We need to police our lake ourselves.
